S. R. O. No. 255/2016.—In exercise of the powers conferred under sections 381, 382, 383A, 387, 398 and 406 of the Kerala Municipality Act, 1994 (20 of 1994), read with section 565 thereof, the Government of Kerala hereby make the following Rules further to amend the Kerala Municipality Building Rules, 1999 issued under G. O. (Ms.) No. 188/1999/LSGD dated 1st October, 1999 and published as S. R. O. No. 777/99 in the Kerala Gazette Extraordinary No. 1786 dated 1st October, 1999, namely:—

33/928/2016/S-2.

RULES

1. *Short title and commencement.*—(1) These Rules may be called the Kerala Municipality Building (Amendment) Rules, 2016.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Kerala Municipality Building Rules, 1999, in Appendix L, after the row covering category Town Planner B, its Qualifications and Functions and before the row covering category Supervisor A, its Qualifications and Functions, the following row with three columns shall be inserted, namely:—

Supervisor Senior	Diploma in Civil Engineering and having 6 years experience as supervisor A,	(i) To prepare and sign building plans and other specifications connected with buildings up to total built up area of 1000 sq.m. or up to four floors
	others having 10 years experience as supervisor A.	or
		(ii) To issue certificates of supervision and completion for buildings coming under item (i) above.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Appendix L of the Kerala Municipality Building Rules, 1999 prescribes qualification and functions of Architect, Engineer etc. registered under the Rules. After considering various representations, the Government decided to create a new category, titled 'Supervisor Senior'. The Government now consider it necessary to make further amendments to the said Rules.

This notification is intended to achieve the above object.
