**S. R. O. No. 380/2017.**—In exercise of the powers conferred by sections 381, 382, 383A, 387, 398 and 406 of Kerala Municipality Act, 1994 (20 of 1994), read with section 565 thereof, Government of Kerala hereby make the following rules further to amend the Kerala Municipality Building Rules, 1999 issued under G. O. (Ms.) No. 188/1999/LSGD dated 1st October, 1999 and published as S.R.O. No. 777/99 in the Kerala Gazette Extraordinary No. 1786 dated 1st October, 1999, namely:—

## RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Municipality Building (Amendment) Rules, 2017.

(2) They shall come into force at once.

2. *Amendment of the Rules.*—In the Kerala Municipality Building Rules, 1999, in sub-rule (6) of rule 150, below the entries “Town Planner B ₹ 5000”, and above the entries “Supervisor A ₹ 3000” the entries “Supervisor Senior ₹ 4500” shall be inserted.

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Government vide S.R.O. No. 255/2016 introduced provision for registration for a new category “Supervisor Senior” in Appendix L of the Kerala Municipality Building Rules by prescribing its qualification and functions. Government now consider it necessary to make further amendments to the said Rules in order to fix the fee for registration and renewal for Supervisor Senior.

This notification is intended to achieve the above object.
