RTI Regarding conversion of unpartitioned residential building to a commercial building occupied by **Chamayam Beauty Parlour & Garments located opp Style Plus shopping complex, Keston Road, Devasomboard Junction, Kowdiar P.O, Trivandrum 695 005.**

1. What are the TC nos. (old & new) allotted by the Corporation to Chamayam Beauty Parlour & Garments for functioning at the aforesaid address?
2. Request the existence & current status of the old TC 11/344, 11/345 & 11/346 residential building. Purpose of these buildings as per your records & when was the survey of these buildings last conducted.
3. The above said building is an unpartitioned one & has 4 legal heirs to the property. The property dispute is still going on in Vanchiyoor Court, Trivandrum (Case No. OS 1841/04 & OS 126/05, now Case No. OS 1429/2010). Under the circumstances, can the said residential building be converted to a business establishment (Chamayam Beauty Parlour & Garments)? Request details for the same.
4. Since the above said property is an unpartitioned property, request the copies of the documents submitted by the applicant for getting approval for the conversion to a business establishment (Chamayam Beauty Parlour & Garments).
5. For converting the Residential building to a Commercial building (Chamayam Beauty Parlour & Garments), has the applicant submitted all necessary documents for getting approval / permission from Town Planning Department? Request copies for the same.
6. Since the above mentioned property is an unpartitioned building, request the circumstances by which permission was granted to the applicant without the consent of the remaining legal heirs. Request copies for Government orders / circulars, if any.
