(Ms.) No. 31/2019/LSGD. dated 7-3-2019:

North : Purathoor Grama Panchayat, Thripangode Gramapanchayath & Bharathapuzha River.

East : Kaladi Grama Panchayat, Edappal Grama Panchayat & Biyyam Kayal.

South : Veliyankode Grama Panchayat, Maranchery Grama Panchayat and Kanjiramukku River.

West : Lakshadweep Sea.

The Municipal Council of Ponnani shall publish the Master Plan as provided under sub-section 10 of section 36 of the Kerala Town and Country Planning Act, 2016.
