G. O. (Ms.) No. 139/13/LSGD. Dated, Thiruvananthapuram, 2nd April, 2013.

S. R. O. No. 287/2013.—WHEREAS, the Government have sanctioned the Detailed Town Planning Scheme for Office Complex, Chalakkudy under sub-section (3) of section 12 of the Town Planning Act, 1108 (Act IV of 1108) vide notification issued under G. O. (Ms.) No. 193/83/LA&SWD dated 5th November, 1983 published as S. R. O. No. 207/84 in section iv, Part I of Kerala Gazette No. 10 dated 6th March, 1984;

AND WHEREAS, it is required to further vary the said scheme for the purpose of making the Zoning Regulations compatible to the present development scenario to the extent possible as an immediate measure, until the scheme is further varied after detailed studies;

NOW, THEREFORE, in exercise of powers conferred by sub-section (2) of section 13 of the Town Planning Act, 1108 (IV of 1108), the Government of Kerala hereby issue a notification varying the said Detailed Town Planning Scheme to the extent required, a draft of which was published vide G. O. (Ms.) No. 165/2011/LSGD, dated 2nd August, 2011 in Part I of Kerala Gazette No. 35 dated 30th August, 2011 as required under clause (b) of sub-section (2) of section 13 of the Town Planning Act, 1108 (Act IV of 1108), read with rule 71 of the Town Planning Rule, 1113 ME.

AMENDMENT

In exercise of the powers conferred by sub-section (2) of section 13 of the Town Planning Act, 1108 (Act IV of 1108), the Government of Kerala hereby vary the Detailed Town Planning Scheme for Office Complex, Chalakkudy sanctioned under sub-section (3) of section 12 of the said Act issued in G. O. (Ms.) No. 193/83/LA&SWD, dated 5th November, 1983, and published as S. R. O. No. 207/84 in Part I of Kerala Gazette No. 10 dated 6th March, 1984 to the extent as indicated below, namely:—

VARIATION

In the said Scheme, for sub-heading "10. Reservation of Land and Zoning" and the entries thereunder, the following shall be substituted, namely:—

"10. Reservation of Land and Zoning

1. All future development shall be in conformity with the provisions of the Detailed Town Planning Scheme for Office Complex, Chalakkudy.
2. For the implementation and enforcement of the proposals envisaged in the Detailed Town Planning Scheme, areas have been zoned under various uses such as residential, commercial, public and semi-public, etc. Details regarding the nature of uses 'permitted', uses 'restricted' and uses 'prohibited' in each zone are given below. In addition to the above, guidelines for regulating developments are also provided herein.
3. (a) "Uses permitted" in a zone cover the uses that can be normally accommodated in the relevant zone.
 (b) In some cases it may be possible to permit some other uses also, which are not likely to affect the quality and environment in a zone specified for a particular use. Such cases have to be individually studied based on their performance characteristics and spatial locational factors. Such cases, which come under this category, are classified as "Uses Restricted".

(c) "Uses Prohibited" enlists the various objectionable uses in each zone, which shall not be permitted under normal circumstances.

In addition to the above, guidelines for regulating developments are also provided herein.

4. Zoning Regulations are not intended to prohibit existing uses that have been lawfully established prior to the enforcement of these regulations. They are essentially intended to help the competent authority in decisions regarding granting or refusal of planning permissions for land use conversions and construction of buildings/structures or any other matter specifically mentioned in these regulations.
5. Existing areas and structures of archeological importance, and religious uses may be permitted to continue in all zones.

- (ii) Regarding the assessment of permissibility of uses classified under the category 'Restricted Uses', the Chief Town Planner may issue general guidelines from time to time, if required and such guidelines shall be adhered to by the Responsible Authorities.
- (iii) For all purpose of this scheme "Area to be acquired for Roads shall be treated as "Area reserved for Roads."

General Guidelines

- (i) All future developments shall be in conformity with the provision of the Detailed Town Planning Scheme and future constructions shall conform to the Kerala Municipal Building Rules in force unless or otherwise specified in this regulations/schemes.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Government have, as per G. O. (Ms) No.193/83/L&SWD dated 5th November, 1983 sanctioned the Detailed Town Planning Scheme for Office Complex, Chalakkudy. Since then, responsible authorities have been enforcing development regulations contained in this sanctioned scheme. Government have reviewed the implementation and enforcement of the scheme and decided to vary the scheme for the purpose of making the zoning regulations of the scheme compatible to the present development scenario. In this respect, Government have as per G. O.(Ms) No.165/2011/LSGD dated 2nd August, 2011 published a draft of the proposal for variation of the scheme as required under sub-section 2(b) of section 13 of Town Planning Act, 1108. Now as required under sub-section 2(a) of section 13 of Town Planning Act 1108, the final notification has to be issued in the Government Gazette, for varying the said Detailed Town Planning Scheme.

This notification is intended to achieve the above object.
